ORDINANCE OF THE MAYOR AND THE CITY COMMISSION OF THE CITY OF WEST MIAMI CODIFYING RESOLUTION 2003-20 ESTABLISHING A CITY OF WEST MIAMI PARKS AND RECREATION ADVISORY BOARD; SETTING FORTH QUALIFICATIONS AND DUTIES FOR SAID BOARD MEMBERS; SETTING GOALS FOR THE ADVISORY BOARD; ESTABLISHING METHODOLOGY OF APPOINTMENTS; PROVIDING FOR CONFLICT CORRECTION; PROVIDING FOR SEVERABILITY; PROVIDING FOR TRANSMITTAL AND PROVIDING FOR EFFECTIVE DATE.

WHEREAS, the City of West Miami Commission adopted Resolution 2003-20 on July 2, 2003, establishing a City of West Miami Parks and Recreation Advisory Board setting forth qualifications and duties of said Board members; and

WHEREAS, the City of West Miami Parks and Recreation Board has served the City well through the years attaining success and positive results which has inured to the welfare of the citizens of the City of West Miami, and

WHEREAS, the City Mayor and City Commission of the City of West Miami desire to formalize and codify said Parks and Recreation Advisory Board in order to attain further achievements in furtherance of services to the citizens of the City of West Miami.

NOW THEREFORE BE IT ORDAINED by the Mayor and City Commission of the City of West Miami as follows:

Section 1. The foregoing "whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Ordinance upon adoption thereof.

Section. 2. Resolution 2003-20 attached hereto as Exhibit A is hereby adopted and incorporated herein as an Ordinance of the City of West Miami.

Section 3. The Mayor of the City of West Miami as presiding officer of the Commission shall be responsible to appoint commissioners and individual residents to the City of West Miami Parks and Recreation Advisory Board.

Section 4. Individual members of the Parks and Recreation Advisory Board shall be residents of the City of West Miami.

Section 5. The Committee shall meet at least on a monthly basis in order to discuss issues, submit recommendations and suggest goals to the City mayor for his recommendation to be included, at his discretion, to the correspondent City Commission agenda.

Section 6. The Mayor of the City of West Miami shall be responsible for the appointment of the Chair of the Advisory Board.

Section 7. All sections or part of sections of the City Code or ordinances or parts of ordinances and all resolutions or part of resolutions in conflict with this ordinance are repealed to the extent of those conflicts.

Section 8. Scrivener's Error. The city attorney may correct scrivener's errors found in this ordinance by filing a corrected copy of this ordinance with the City Clerk.

Section 9. This ordinance shall become effective upon its adoption and approval by the Mayor and City Commission, as provided by the Charter of the City of West Miami.





RESOLUTION OF THE CITY OF WEST MIAMI, FLORIDA, ESTABLISHING A CITY OF WEST MIAMI PARKS AND RECREATION ADVISORY BOARD AND SETTING FORTH THE QUALIFICATIONS AND DUTIES FOR SAID BOARD MEMBERS

WHEREAS, the Mayor and City Commission of the City of West Miami, Florida wishes to establish an advisory board to assist the City in setting goals and bringing forth projects to carry out the goals for the City's parks and it's Recreation Center; and

WHEREAS, the City Commission must establish priorities for the Capital Improvements Schedule within the Parks and Recreation element of the City's Comprehensive Plan, and requires assistance in doing so: and

WHEREAS, the City of West Miami desires to apply for future Land and Water Conservation Fund Grants, Florida Recreation Development Assistance Program and other available grants to assist in funding within it's recreation areas; and

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COMMISSION OF THE CITY OF WEST MIAMI that:

SECTION 1. The City Commission hereby establishes the City of West Miami Parks and Recreation Advisory Board. This Board shall consist of a City Commission member appointed by the City Commission to serve as Board Chairman, the Parks and Recreation Director and three West Miami citizens appointed by the City Commission.

SECTION 2. The Parks and Recreation Advisory Board shall meet at least every two months or as often as required to meet the duties of the Board.

SECTION 3. The Parks and Recreation Advisory Board shall be responsible for establishing a priority list of unmet needs within the City's parks and the Recreation Center. They shall assist the City Manager and Parks and Recreation Director in the selection and planning for park, recreation and leisure service programs and activities.

SECTION 4. The Parks and Recreation Advisory Board shall be responsible for establishing a priority list of Capital Improvement needs within the parks and the Recreation Center.


SECTION 5. The Parks and Recreation Advisory Board shall prepare agendas and minutes of all meetings and shall submit recommendations as needed to the City Manager and City Commission.
