**NOW THEREFORE, BE IT RESOLVED BY THE CITY OF WEST MIAMI, FLORIDA as follows:**


**Section 1.** The Tentative Budget 2025-2026 as submitted by the City Manager is hereby adopted and attached hereto as if fully set forth herein.
