



RESOLUTION #2012-10

A RESOLUTION OF THE CITY OF WEST MIAMI, FLORIDA, ESTABLISHING THE CITY OF WEST MIAMI 2012-2014 COMMITTEE(S), COMMITTEE(S) STRUCTURE IN THE CITY OF WEST MIAMI TO INCLUDE APPOINTMENTS AND TERMS; ESTABLISHING COMMITTEE NAMES AND ANY OTHER COMMITTEES, PROVIDING FOR APPOINTMENT METHODOLOGY, PROVIDING FOR EFFECTIVE DATE.

WHEREAS, pursuant to Section 3.8 of the City of West Miami Code, the Mayor shall preside meetings of the council; and

WHEREAS, it has been the tradition in the City of West Miami that the Mayor appoint members of the Commission to various City Committees; and

WHEREAS, the appointment of commissioners to various committees would enable the commission to benefit from the investigation and research of individual members in their respective areas; and

WHEREAS, it is necessary to determine the committees, committee appointments and terms of individual commissioners to the individual committees; and

WHEREAS, it is necessary to establish a methodology to determine the effectiveness of each committee; and

NOW, THEREFORE, BE IT RESOLVED by the City Commission of the City of West Miami as follows:

Section 1. That the Mayor of the City of West Miami shall have, as presiding officer of the City Commission, the authority to establish committees, appoint commissioners to individual committees and establish the roles of said committees.

Section 2. That the Committees shall meet at the designated time and place, to entertain and discuss issues, submit recommendations and suggest findings to the City Mayor for his recommendation to be included in the corresponding agenda.

Section 3. That the Mayor shall assign a Committee head who shall report to the City Mayor at least two times per month with any findings, recommendations and or suggestions as to any issue.

Section 4. It shall be the responsibility of each Committee head to fulfill their duties pursuant to this Resolution.

Section 5. This Resolution shall become effective immediately upon its passage. All Resolutions and parts of Resolutions in conflict herewith are repealed.
