RESOLUTION OF THE CITY OF WEST MIAMI AMENDING SECTION 1. OF RESOLUTION # 2008-18 (A) , INTRODUCING A TIERED SYSTEM FOR SUMMER CAMP FEES AND AFTER SCHOOL FEES FOR NON-RESIDENTS PARTICIPATING IN THE CITY OF WEST MIAMI RECREATION CENTER, PROVIDING FOR SIBBLING DISCOUNT RATES, PROVIDING FOR EFFECTIVE DATE.

Whereas, The City of West Miami would like to attract new families to participate in the summer camp and after school programs for children six and over; and

Whereas, The City of West Miami wishes to amend the fees associated with summer camp and after school programs at the City of West Miami Recreation Center; and

Whereas, With the recent completion of the Rebeca Sosa Multipurpose Facility the City is now able to increase the capacity for new program participants; and

Whereas, The Mayor and City Commission have received a recommendation associated with the summer camp and after school fees for non-residents to offer a discounted sibling summer camp and after school fees for families who are registering more than one child of the immediate family.

NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COMMISSION OF THE CITY OF WEST MIAMI as follows:

Section 1. The City Administration is hereby authorized to collect the following summer camp weekly fees from non-residents six years old and over attending the summer camp program offered at the City of West Miami Recreation Center:

a) Non Resident Summer Camp fees :

Section 2. The City Administration is hereby authorized to collect the following after school monthly fees from non-residents elementary school students six years old and over participating in the after school program offered at the City of West Miami Recreation Center:

b) Non Resident After School fees :

| 4th child and subsequent | \$10.00 monthly |
