**RESOLUTION OF THE MAYOR AND THE CITY COMMISSION OF THE CITY OF WEST MIAMI RESCINDING RESOLUTION NUMBER 2012-13 TITLED "RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF WEST MIAMI AUTHORIZING THE CITY MANAGER TO PURCHASE ADMINISTRATIVE POLICE VEHICLE FOR WEST MIAMI POLICE DEPARTMENT AS A REPLACEMENT VEHICLE, TO BE FUNDED FROM EQUITABLE SHARING ACCOUNT AT NO COST TO THE TAXPAYER; PROVIDING FOR EFFECTIVE DATE, PASSED AND ADOPTED ON MAY 16<sup>TH</sup>, 2012"; PROVIDING FOR EFFECTIVE DATE.**


