



## RESOLUTION # 2012-38

RESOLUTION OF THE CITY OF WEST MIAMI, FLORIDA AUTHORIZING THE CITY MANAGER TO APPLY FOR TWO FY 2013 FLORIDA RECREATION DEVELOPMENT ASSISTANCE PROGRAM (FRDAP) GRANTS TO COMPLETE FIFTY THOUSAND DOLLARS (\$50,000.00) IN IMPROVEMENTS AT EDMUND COOPER PARK (REPLACEMENT OF PLAYGROUND EQUIPMENT) AND TO COMPLETE FIFTY THOUSAND DOLLARS (\$50,000.00) IN IMPROVEMENTS AT THE RECREATION CENTER (REPLACE WIRING TO THE BASKETBALL AND TENNIS COURTS AND POSSIBLY REFURBISH PLAYGROUND EQUIPMENT AND CREATE A PICNIC AREA DEPENDING UPON COST ESTIMATES NOT YET RECEIVED). FURTHER AUTHORIZING THE CITY MANAGER TO EXECUTE THE APPROPRIATE AGREEMENTS AND AMENDMENTS FOR SAID GRANT AND TO APPLY FOR, RECEIVE AND EXPEND FUNDS FOR THE STATED PURPOSE.

**WHEREAS**, the Mayor and City Commission of the City of West Miami, Florida desire to accomplish the improvements set forth in the Capital Improvements section of the City's Comprehensive Plan.

**WHEREAS**, the Mayor and City Commission of the City of West Miami, Florida wish to take full advantage of the funding available through the Florida Recreation Development Assistance Program grants to replace the playground equipment at Edmund Cooper park, replace the wiring for the lighting of the basketball and tennis courts, replace the playground equipment and construct a picnic area at the Recreation Center.

**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COMMISSION OF THE CITY OF WEST MIAMI THAT:**

SECTION 1. The City Commission hereby authorizes Yolanda Aguilar, City Manager, to apply for two \$50,000.00 grants through the Florida Recreation Development Assistance Program to accomplish the above stated improvements.

SECTION 2. The City Commission hereby authorizes Yolanda Aguilar, City Manager to execute any contracts for same and to expend any and all monies received for the purpose described in the funding request; to receive and expend any additional funds that might become available during the term of the grant; to file and execute necessary amendments to the contract for and on behalf of the City of West Miami, Florida; and to exercise amendment, modification, renewal, cancellation and termination clauses of any contracts and agreements on behalf of the City of West Miami, Florida.

SECTION 3. This Resolution shall take effect immediately upon passage by the City Commission and signature of the Mayor.


