RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF WEST MIAMI AUTHORIZING THE CITY MANAGER TO IMPLEMENT AN ONLINE PAYMENT OPTION FOR PAYMENT OF UTILITY BILLS (WATER, SEWER, STORMWATER AND GARBAGE FEES) AND AUTHORIZING THE CITY MANAGER TO ENTER INTO A CONTRACT AGREEMENT WITH XEROX (SOFTWARE PROVIDER) FOR THE PURPOSE OF MODIFYING THE SOFTWARE THAT IS REQUIRED FOR THE CITY TO IMPLEMENT THE ONLINE PAYMENT OPTION; PROVIDING FOR AN AMOUNT OF TWO THOUSAND TWO HUNDRED DOLLARS (\$2,200.00) TO BE FUNDED WITH THE USE OF IMPACT FEES FOR GENERAL SERVICES AND UTILITIES; PROVIDING FOR EFFECTIVE DATE.

WHEREAS, Xerox Government Systems, LLC has been a long standing service provider of software services for the City of West Miami; and

WHEREAS, the advance of technology has made it available superior services to consumers within the City of West Miami; and

WHEREAS, the City of West Miami finds that is necessary to expand and upgrade the services provided to the citizens of West Miami; and

WHEREAS, the Mayor and City Commission of the City of West Miami find adequate to implement the online payment option for the satisfaction of utility bills, such as water, sewer, stormwater and garbage fees; and

WHEREAS, Xerox, through its contractors can provide such services to the citizens of the City of West Miami.

NOW, THEREFORE, BE IT RESOLVED by the City Commission of the City of West Miami as follows:

SECTION 1. The aforementioned statements are true and correct and adopted as is fully stated herein.

SECTION 2. The City Commission hereby authorizes the City Manager to enter into an Agreement with Xerox for professional software services in the amount of \$2,200.00.

SECTION 3. This Resolution shall take effect immediately upon passage by the City Commission and signature of the Mayor.


