



RESOLUTION # 2014-45

RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF WEST MIAMI AUTHORIZING THE CITY MANAGER TO ESTABLISH THE 2014-2015 AFTERSCHOOL CARE PROGRAM RESIDENT/NON RESIDENT FEES, AND THE 2015 SUMMER CAMP FEES FOR RESIDENTS/NON-RESIDENTS AND CITY EMPLOYEES WHOSE CHILDREN ATTEND SUMMER CAMP AND AFTER SCHOOL CARE PROGRAMS OFFERED BY THE CITY OF WEST MIAMI; PROVIDING FOR EFFECTIVE DATE.

Whereas, The City of West Miami wishes to amend the fees associated with the After School Program and Summer Camp at the City of West Miami Recreation Center for residents, non-residents and City employees; and

Whereas, The Mayor and City Commission have received a recommendation associated with the After School fees and Summer Camp fees for residents, non-residents and City employees.

NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COMMISSION OF THE CITY OF WEST MIAMI as follows:

Section 1. The aforementioned statements are true and correct and adopted as is fully stated herein.

Section 2. The City Administration is hereby authorized to collect the following After School and Summer Camp fees from residents, non-residents and City employees whose children attend the programs offered at the City of West Miami Recreation Center:

a) Resident After School fees:

1st child:	\$ 40.00 monthly
1 st and 2 nd child	\$ 64.00 monthly
1 st , 2 nd and 3 rd child	\$ 80.00 monthly
4 th child and subsequent	\$ 10.00 monthly

b) Non-Resident After School fees :

1st child:	\$120.00 monthly
1 st and 2 nd child	\$192.00 monthly
1 st , 2 nd and 3 rd child	\$240.00 monthly
4 th child and subsequent	\$10.00 monthly

c) City Employees After School fees:

1st child:	\$ 40.00 monthly
1 st and 2 nd child	\$ 64.00 monthly
1 st , 2 nd and 3 rd child	\$ 80.00 monthly
4 th child and subsequent	\$ 10.00 monthly

d) Late fee for pick-up after 6:00 P.M

\$ 5.00 Late Fee

e) Resident Summer Camp fees:

1st child:	\$ 30.00 weekly
1 st and 2 nd child	\$ 60.00 weekly
1 st , 2 nd and 3 rd child	\$ 90.00 weekly
4 th child and subsequent	\$ 120.00 weekly

f) Non Resident Summer Camp fees:

1st child:	\$ 90.00 weekly
1 st and 2 nd child	\$144.00 weekly
1 st , 2 nd and 3 rd child	\$180.00 weekly
4 th child and subsequent	\$10.00 weekly

g) City Employees Summer Camp Fees:

1st child:	\$ 30.00 weekly
1 st and 2 nd child	\$ 60.00 weekly
1 st , 2 nd and 3 rd child	\$ 90.00 weekly
4 th child and subsequent	\$ 120.00 weekly

Section 8. This Resolution shall become effective immediately upon its passage. All Resolutions and parts of Resolutions in conflict herewith are repealed.
