RESOLUTION OF THE MAYOR AND THE CITY COMMISSION OF THE CITY OF WEST MIAMI AUTHORIZING THE CITY MANAGER TO IMPLEMENT A STRUCTURED TUTORING PROGRAM AT THE WEST MIAMI RECREATION CENTER; ADOPTING A PROGRAM PLAN FOR SAID TUTORING; PROVIDING FOR FUNDING MECHANISM TO COME FROM CITY OF WEST MIAMI RECREATION CENTER ENTERPRISE FUND; PROVIDING FOR ADMINISTRATION OF THE PROGRAM; PROVIDING FOR 10/01/ 2014 PROGRAM COMMENCEMENT DATE.

WHEREAS, the Mayor and City Commission of the City of West Miami, Florida desire to accomplish the implementation of a tutoring program at the West Miami Recreation Center; and

WHEREAS, The City of West Miami has had tutoring program in the past as an additional service to the residents and non-residents who used the afterschool program; and

WHEREAS, The establishment of the tutoring program requires funding and structure to that it becomes and successful and viable program; and

WHEREAS, The goal is to assist every grade level by providing them with small groups that target reading and math subject matters; and

WHEREAS, The City Manager and Recreation Center Director have recommended the implementation of the structured tutoring program at the West Miami Recreation Center commencing on October 7th, 2014 through May 2015; and

WHEREAS, The office of the City Manager further recommends the utilization of five thousand dollars (\$5,000.00) by taking the first year from reserves and subsequently pursue grants and other funding opportunities.

NOW, THEREFORE, BE IT RESOLVED by the City Commission of the City of West Miami as follows:

SECTION 1. The aforementioned statements are true and correct and adopted as is fully stated herein.

SECTION 2. The City Manager is hereby authorized the expenditure of five thousand dollars (\$5,000.00) to implement the tutoring program at the West Miami Recreation Center utilizing Recreation Center funds.

SECTION 3. This Resolution shall take effect immediately upon passage by the City Commission and signature of the Mayor.
