



RESOLUTION # 2016-08

RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF WEST MIAMI AUTHORIZING THE CITY MANAGER TO ENTER INTO AN AGREEMENT WITH RICHWOOD LANDSCAPING, MAINTENANCE AND IRRIGATION FOR AN AMOUNT OF NINETEEN THOUSAND FIVE HUNDRED TWENTY DOLLARS AND ZERO CENTS (\$19,520.00) IN CONNECTION WITH NEW LANDSCAPING INSTALLATION AT GARDEN CLUB PARK; PROVIDING FOR FUNDING OF TEN THOUSAND DOLLARS (\$10,000.00) FROM THE FLORIDA URBAN FORESTRY GRANT AND MATCHING TEN THOUSAND DOLLARS (\$10,000.00) FROM PARK IMPACT FEES; PROVIDING FOR EFFECTIVE DATE.

WHEREAS, the Mayor and City Commission of the City of West Miami, Florida desire to accomplish the purpose outlined in the accompanying proposal; and

WHEREAS, the proposal for installation of landscaping at Garden Club Park in the amount of nineteen thousand five hundred twenty dollars and zero cents (\$19,520.00) has been found to be acceptable; and

WHEREAS, the City Manager and Public Works Director have recommended the acceptance of the above referenced proposal.

NOW, THEREFORE, BE IT RESOLVED by the City Commission of the City of West Miami as follows:

SECTION 1. The aforementioned statements are true and correct and adopted as is fully stated herein.

SECTION 2. The City Commission hereby authorizes the City Manager to accept the proposal of nineteen thousand five hundred twenty dollars and zero cents (\$19,520.00) from Richwood Landscaping.

SECTION 3. The funds to further the purposes described in the funding request shall be paid from Florida Urban Forestry Grant and Park Impact Fees Funds.

SECTION 4. This Resolution shall take effect immediately upon passage by the City Commission and signature of the Mayor.
