RESOLUTION OF THE MAYOR AND THE CITY COMMISSION OF THE CITY OF WEST MIAMI AUTHORIZING THE CITY MANAGER TO EXECUTE A RENEWAL TO THE CONTRACT BETWEEN THE CITY OF WEST MIAMI AND GREATER MIAMI CATERING SERVICE FOR SERVICES IN CONNECTION WITH THE CONGREGATE HOMEDELIVERED MEAL SERVICE AS PART OF THE WEST MIAMI COMMUNITY CENTER ELDERLY PROGRAM, PROVIDING FOR NON-MONETARY CONTRACT EXTENSION, AS "YEAR ONE" OF THE FOUR ADDITIONAL ONE YEAR OPTIONS OF RENEWAL THAT WILL ALLOW THE CONTRACT TO CONTINUE THROUGH SEPTEMBER 30TH, 2017, RESULTING IN THE CONTINUATION OF THE EXISTING RATES OF (1) CONGREGATE MEAL PRICE OF \$2.96 AND A HOME-BOUND MEAL PRICE OF \$3.84, PROVIDING FOR AN OCTOBER 1ST, 2016 EFFECTIVE DATE.

WHEREAS, the Mayor and City Commission of the City of West Miami, Florida on September 23rd, 2016 adopted Resolution # 2015-53 authorizing the City Manager the execution of a contract with Greater Miami Caterers, Inc. for a period of five (5) years commencing on October 1st, 2015 and ending on September 30th, 2016 with the option to renew for four (4) additional twelve months (12) for a total of five years (5) to provide for Congregate and Home Delivered Nutrition Programs for the elderly; and

WHEREAS, Greater Miami Caterers, Inc. has proposed a congregate meal unit price of \$ 2.96; and

WHEREAS, Greater Miami Caterers, Inc. has proposed a home-bound meal unit price of \$ 3.84; and

WHEREAS, the City Manager and the Director of the Community Center have recommended the non-monetary contract extension as "Year one" of the four additional one year options.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COMMISSION OF THE CITY OF WEST MIAMI THAT:

SECTION 1. The City Commission hereby authorizes the City Manager to execute an extension for one year of four year options with Greater Miami Caterers, Inc. Agreement for food catering services rendered to the West Miami Community Center.

SECTION 2. This Resolution shall take effect immediately upon passage by the City Commission and signature of the Mayor.



Dear Ms. Aguilar,

As per the contractual specifications contained in your bid of September 10th, 2015, Greater Miami Caterers, Inc. is submitting the following:

- 1) That we would be happy to accept, if offered by the City of West Miami, an extension of the current catering contract #2015-CC that includes our required 90-day notification period that would be prior to July 1st, 2016 for renewal on October 1st, 2016.
- 2) The terms of this renewal as delineated in the bid would be for one additional year. This is the first year of the four additional one year options of renewal that will allow the contract to continue through September 30, 2017.
- 3) As per the contract, prices are to remain fixed for the first two years of service.
- 4) This would result in a continuation of the existing rates of: a. Congregate Meal price of \$2.96 and a Home-Bound Meal price of \$3.84.
