



RESOLUTION # 2016-36

A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF WEST MIAMI APPOINTING JOHN MICHAEL LOPEZ TO THE POSITION OF RECREATION DIRECTOR; PROVIDING FOR A COMPENSATION PACKAGE, PROVIDING FOR SEVERABILITY; PROVIDING FOR AN IMMEDIATE EFFECTIVE DATE.

Whereas, the Mayor and City Commission under the provisions of the City Charter, Section 4.04 a) -"The City Manager shall: Nominate persons for appointment as directors of the Police Department, Public Works Department, and Recreation Department (and any other departments created by ordinance or resolution of the City Council) subject to ratification and confirmation by a majority vote of the full City Council. Council approval shall not be necessary for the Manager to suspend or remove such department directors. He shall appoint, and when he deems it necessary for the good of the City suspend or remove all other City employees and appointive administrative officers provided for by or under this Charter, except as otherwise provided by law, this Charter or personnel rules adopted pursuant to this Charter. He may authorize any administrative officer who is subject to his direction and supervision to exercise these powers with respect to subordinates in that officer's department, office or agency; and

Whereas, the Recreation Director position must be filled by a qualified individual who will carry out the duties and responsibilities of the Recreation Department.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COMMISSION OF THE CITY OF WEST MIAMI THAT:

Section 1. John Michael Lopez is hereby appointed as Recreation Director of the City of West Miami.

Section 2. John Michael Lopez will be compensated an annual amount of \$ 40,000.00 per year as the Recreation Director.

Section 3. John Michael Lopez will continue to enjoy the same benefits afforded to him at present to include the vacation time, sick leave, holiday schedule, medical, dental and life insurance (as a class one classification) and Florida Retirement System.

Section 4. Any/all toll expense, meeting expense be reimbursed with the proper justification and receipts for City business.

Section 6 This resolution be forwarded to the Office of the City Manager and Finance Director for the purpose of establishing the above mentioned compensation packet for John Michael Lopez with an effective date of July 20th, 2016.


