



RESOLUTION # 2016-41

RESOLUTION OF THE MAYOR AND THE CITY COMMISSION OF THE CITY OF WEST MIAMI AUTHORIZING THE CITY MANAGER TO LEASE/PURCHASE THREE VEHICLES FOR THE POLICE DEPARTMENT; ONE SLICK TOP A-I-D TRAFFIC VEHICLE FUNDED FROM LETF FOR THE AMOUNT OF THIRTY NINE THOUSAND SEVEN HUNDRED EIGHTY-TWO DOLLARS (\$39,782.00) AND TWO POLICE CRUISERS FOR PATROL USE TO BE FUNDED FROM IMPACT FEES IN THE AMOUNT OF THIRTY FOUR THOUSAND SEVEN HUNDRED EIGHTY-TWO DOLLARS EACH (\$ 34,782.00); PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, The West Miami Police Department is in need of a slick top A-I-D traffic vehicle and two police cruisers as replacement vehicles.

WHEREAS, The City Manager has recommended that the City lease/purchase one slick A-I-D traffic vehicle and two police cruisers for patrol use.

NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COMMISSION OF THE CITY OF WEST MIAMI THAT:

SECTION 1. The aforementioned statements are true and correct and adopted as is fully stated herein.

SECTION 2. The Mayor and City Commission hereby authorize the City Manager to purchase one slick A-I-D traffic vehicle funded from LETF Funds in the amount of \$39,782.00 and two police cruisers, one funded from Impact Fees for \$34,782.00 to be reimbursed to the General Fund after passage of the 2016-2017 budget and the other funded from Impact Fees.


SECTION 3. This Resolution shall take effect immediately upon passage by the City Commission and signature by the Mayor.
