**RESOLUTION BY THE MAYOR AND CITY COMMISSION OF THE CITY OF WEST MIAMI AUTHORIZING THE CITY MANAGER TO RECEIVE A DONATION FROM CITIZEN MARK CERECEDA IN THE AMOUNT OF \$15,050.00 FOR THE PURCHASE OF ASR RESPONSE KITS FOR THE WMPD AND AUTHORIZING THE CITY MANAGER TO UTILIZE THE DONATION TO PURCHASE 35 ASR (ACTIVE RESPONSE KITS) FROM FEDERAL EASTERN INTERNATIONAL AT A PRICE OF \$430.00 PER KIT FOR THE WEST MIAMI POLICE DEPARTMENT TO INSURE ADDITIONAL PROTECTIVE WEAR; PROVIDING FOR EFFECTIVE DATE.**

**WHEREAS**, Citizen Mark Cereceda has donated the amount of fifteen thousand dollars (\$ 15,000.00) to the City of West Miami, said amount to be used towards the purchase of 35 active shooter response kits from Federal Eastern International at a price of \$430.00 per kit.

**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COMMISSION OF THE CITY OF WEST MIAMI THAT:**

**SECTION 1.** The aforementioned statements are true and correct and adopted as is fully stated herein.

**SECTION 2.** The City Commission hereby authorizes the City Manager to accept the donation of fifteen thousand dollars from Citizen Mark Cereceda to further the above described purpose.

**SECTION 3.** This Resolution shall take effect immediately upon passage by the City Commission and signature of the Mayor.


