



RESOLUTION # 2016-45

RESOLUTION AUTHORIZING THE CITY MANAGER TO EXECUTE A NON-MONETARY EXTENSION OF TIME CONTRACT WITH FLORIDA INTERNATIONAL UNIVERSITY FOR THE PURPOSE OF COMPLETING THE CITY'S MASTER PLAN UPDATE AS APPROVED BY RESOLUTIONS # 2015-09 AND # 2015-58, PROVIDING FOR A CONTINUANCE OF THE "PROJECT PERIOD" WITHOUT INTERRUPTION UNTIL DECEMBER 30TH, 2016, PROVIDING FOR NEW TIMELINES, PROVIDING FOR EFFECTIVE DATE.

WHEREAS, the Mayor and City Commission of the City of West Miami, Florida on February 4th, 2015 passed and adopted Resolution # 2015-09, pursuant to a proposal by the Florida International University, which authorized the City Manager the expenditure of thirty seven thousand dollars in connection with the update of the 2005 City of West Miami Comprehensive Plan and the Evaluation and Appraisal Report; and

WHEREAS, the parties wish to modify the agreement so that the "Project Period" shall continue without interruption until December 30th, 2016; and

WHEREAS, the aforesaid No Cost Extension period will allow the Metropolitan Center staff time to complete the submittal of findings and final report.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COMMISSION OF THE CITY OF WEST MIAMI THAT:

SECTION 1. The aforementioned statements are true and correct and adopted as is fully stated herein.

SECTION 2. The Mayor and City Commission of the City of West Miami hereby authorize the Office of the City Manager to accept the request for extension by the Florida International University for the purpose of completing the task of updating the 2005 City's Comprehensive Plan and the Evaluation and Appraisal Report.

SECTION 3. This Resolution shall take effect immediately upon passage by the City Commission and signature of the Mayor.


