



RESOLUTION # 2016-48

A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF WEST MIAMI AUTHORIZING THE CITY MANAGER TO EXECUTE A ONE (1) YEAR EXTENSION OF CONTRACT WITH MIAMI DADE COUNTY OFFICE OF PUBLIC HOUSING AND COMMUNITY DEVELOPMENT COMMENCING JANUARY 1ST, 2017 THROUGH DECEMBER 30TH, 2017 FOR THE COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) AWARD IN THE AMOUNT OF \$125,000.00 FOR THE EXPANSION OF THE GARDEN CLUB PARK; PROVIDING FOR EFFECTIVE DATE.

WHEREAS, the City acquired certain property located at 1129 SW 66 Avenue, West Miami, Florida utilizing park impact fees; and

WHEREAS, the City of West Miami Commission has decided to demolish the property located at 1129 SW 66 Avenue, for the purpose of park expansion in order to meet concurrency and growth requirements pursuant to the City Comprehensive Plan; and

WHEREAS, City applied and the County has approved, a CDBG Grant in the amount of \$125,000.00 which would be matched by the City with funds collected in impact fees; and

WHEREAS, the County has provided a contract for the execution by the City in order to provide the \$125,000.00 grant.

WHEREAS, the City of West Miami needs to accomplish the extension of the aforementioned contract for the period covering January 1st, 2017-December 30th, 2016.

NOW, THEREFORE, BE IT RESOLVED by the City Commission of the City of West Miami as follows:

- Section 1.** The aforementioned statements are true and correct and adopted as is fully stated herein.
- Section 2.** The City Manager is hereby instructed to execute the extension of contract with Miami-Dade County for CDBG matching grant.

Section 3. This Resolution shall become effective immediately upon passage. All Resolutions or parts of Resolutions in conflict herewith are repealed.
