



RESOLUTION # 2016-70

RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF WEST MIAMI AUTHORIZING THE CITY MANAGER TO ACCEPT A MITIGATION OFFER IN THE AMOUNT OF ONE THOUSAND FIVE HUNDRED DOLLARS (\$1,500.00) FROM WEST MIAMI HOLDINGS, LLC. ON CODE ENFORCEMENT LIEN FOR CODE VIOLATION AT THE PROPERTY LOCATED AT 6540 SW 16 STREET, WEST MIAMI, FL; PROVIDING THAT IF PAYMENT IN FULL IS NOT PAID BY DECEMBER 2ND, 2016 THEN THE AMOUNT OWED SHALL REVERT TO THE ORIGINAL AMOUNT; PROVIDING FOR EFFECTIVE DATE.

WHEREAS, a Code Enforcement liens for Code violations through **Case #1507056** in the amount of \$ 10,889.00 has been levied against the property located at 6540 SW 16th Street , West Miami, Florida; and

WHEREAS, the Mayor and City Commission have received a negotiated settlement offer in the amount of One Thousand Five Hundred Dollars and Zero Cents (\$1,500.00) .

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COMMISSION OF THE CITY OF WEST MIAMI AS FOLLOWS:

SECTION 1. The City Manager is hereby authorized to accept the mitigation offer in the amount of One Thousand Five Hundred Dollars and Zero Cents (\$1,500.00) from West Miami Holdings, LLC. to settle Code Enforcement lien for Code Violation at 6540 SW 16th Street West Miami, Florida, and subsequently release said liens.

SECTION 2. This settlement is contingent upon payment of amount on **Section 1** on or before **December 2nd, 2016 and removal of cages from the premises.** If said amount and settlement are not paid by this date the amount owed in **Case #1507056** in the amount of \$ 10,889.00, will revert to the original amount.

SECTION 3. This Resolution shall take effect immediately upon passage by the City Commission and signature of the Mayor.


