RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF WEST MIAMI AUTHORIZING THE CITY MANAGER THE EXPENDITURE OF EIGHT THOUSAND NINE HUNDRED THIRTY DOLLARS (\$8,930.00) FOR THE PURPOSE OF ACCOMPLISHING THE COOPER PARK ELECTRICAL IMPROVEMENTS DAMAGED BY HURRICANE IRMA ON SEPTEMBER 8TH, 2017; PAYABLE TO T.Y. LIN INTERNATIONAL TO PROVIDE PROFESSIONAL ENGINEERING SERVICES FOR THE PREPARATION OF CONSTRUCTION DOCUMENTS, PERMITTING ASSISTANCE AND CONSTRUCTION ADMINISTRATION FOR THE PROPOSED IMPROVEMENTS; FUNDED FROM HURRICANE NATIONAL DISASTER ACCOUNT 529-470; PROVIDING FOR EFFECTIVE DATE.

WHEREAS, the Mayor and City Commission of the City of West Miami, Florida desire to accomplish the re-wiring of the existing electrical service panel that provides power to the park for lighting and miscellaneous power; and

WHEREAS, the proposal submitted by T.Y. Lin International in the amount of eight thousand nine hundred thirty dollars (\$8,930.00) has been found to be acceptable; and

WHEREAS, the City Manager and Public Works Director have recommended the approval of the above referenced proposal.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COMMISSION OF THE CITY OF WEST MIAMI THAT:

SECTION 1. The aforementioned statements are true and correct and adopted as is fully stated herein.

SECTION 2. The City Commission hereby authorizes the City Manager to accept the proposal from T.Y. Lin International in the amount of eight thousand nine hundred thirty dollars (\$8,930.00).

SECTION 3. The funds to further the purposes described in the funding request shall be paid as follows:

SECTION 4. This Resolution shall take effect immediately upon passage by the City Commission and signature of the Mayor.
