RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF WEST MIAMI AUTHORIZING THE CITY MANAGER TO RENEW AND EXTEND THAT CERTAIN AGREEMENT WITH AMERICAN TRAFFIC SOLUTIONS, INC. (ATS) D/B/A VERRA MOBILITY (VERRA) ORIGINALLY ENTERED INTO ON JUNE 11, 2009 AND SUBSEQUENTLY AMENDED ON JULY 9, 2010, DECEMBER 5, 2012 AND JULY 2013 TO ENHANCE THE CITY OF WEST MIAMI'S RED LIGHT SAFETY PROGRAM THAT WOULD INCLUDE TAKING ADVANTAGE OF NEW TECHNOLOGY AND LOWER COSTS; EXTEND THE TERMS AND CONDITIONS OF THE PREVIOUS CONTRACT AND AMENDMENTS FOR THREE(3) YEARS WITH THE OPTION TO RENEW FOR TWO (2) ADDITIONAL YEARS; PROVIDING FOR EFFECTIVE DATE.

WHEREAS, the City of West Miami entered into an agreement with ATS on May 2009 for the installation and maintenance of red light safety program through the City of West Miami; and

WHEREAS, the City may, at its discretion, extend a successful contract; and

WHEREAS, the City entered into a contract with American Traffic Solutions, Inc. (ATS) d/b/a Verra Mobility (VERRA) on June 11, 2009 and subsequent amendments on July 9, 2010, December 5, 2012 and July 2013;

WHEREAS, a copy of the proposed fourth amendment is attached as Exhibit A; and

WHEREAS, the Chief of Police, Nelson Andreu has negotiated a reduction in the monthly fee for all currently installed and expansion camera systems to \$4,250.00; and

WHEREAS, the Chief of Police has further negotiated additional HD video for compatible enforcement camera systems; and

WHEREAS, the City Commission has found that the terms and conditions offered and negotiated by the Chief of Police and ATS to be acceptable.

NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COMMISSION OF THE CITY OF WEST MIAMI THAT:

SECTION 1. The aforementioned statements are true and correct and adopted as is fully stated herein.


SECTION 2. The City Commission hereby approves that negotiated contract extension with ATS for the enhancement of the red light safety program throughout the City of West Miami.

SECTION 3. The City Commission approves of the reduced monthly fee of \$4,250.00 per month for the red light safety program.

SECTION 4. The City Manager is hereby authorized to renew and enter into an extended contract with ATS for an additional three years with the option to renew for two additional years.

SECTION 5. This Resolution shall take effect immediately upon passage by the City Commission and signature of the Mayor.
