



RESOLUTION # 2020-38

A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF WEST MIAMI AUTHORIZING THE CITY MANAGER TO EXECUTE THAT CERTAIN INTERLOCAL AGREEMENT WITH MIAMI-DADE COUNTY TO OBTAIN PASS-THROUGH FUNDING FOR A FEDERAL AWARD TO ENSURE THE EFFECTIVE AND TIMELY DISSEMINATION AND ALLOCATION OF CORONA RELIEF FUNDS (CRF) DOLLARS REIMBURSING THE CITY OF ELIGIBLE ACTIVITIES UNDER THE CORONA VIRUS AID, RELIEF AND ECONOMIC SECURITY ACT (CARES ACT); PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Coronavirus Pandemic that has currently battered the entire world has devastated local communities throughout the United States; and

WHEREAS, multiple executive orders by the Governor of the State of Florida and the Mayor of Miami-Dade County have severely impacted the economy of the City of West Miami; and

WHEREAS, Miami-Dade County serves as a pass-through entity for Federal Award to municipal recipients; and

WHEREAS, this Interlocal Agreement will serve to ensure that proper funding will timely allocate Corona Relief Funds (CRF) dollars to reimburse the City of West Miami for eligible activities/expenditures under the Corona Virus Aid and Economic Security Act (CARES Act); and

WHEREAS, the City of West Miami desires to authorize the City Manager to execute the Interlocal Agreement for federally funded subaward as attached hereto and made a part hereof as Exhibit "A".

NOW, THEREFORE, BE IT RESOLVED by the City Commission of the City of West Miami as follows:

Section 1. The aforementioned statements are true and correct and adopted as is fully stated herein.

Section 2. The City Mayor and City Commission hereby authorize the City Manager to enter into an Interlocal Agreement with Miami-Dade County for federally funded subaward outlined in the agreement attached as Exhibit A.

Section 3. This Resolution shall take effect immediately upon passage by the City Commission and signature of the Mayor.
