RESOLUTION BY THE MAYOR AND CITY COMMISSION OF THE CITY OF WEST MIAMI APPROVING THE 2020 LOCAL STRATEGY MITIGATION PLAN FOR THE CITY OF WEST MIAMI ADOPTING THE MIAMI DADE COUNTY LOCAL MITIGATION STRATEGY PLAN AS SUBMITTED TO THE STATE OF FLORIDA; AUTHORIZING THE OFFICE OF THE CITY MANAGER TO APPLY FOR FUNDS FOR PROJECTS THAT ARE SPECIFICALLY AIMED TO MITIGATE AND HARDEN THE CITY'S INFRASTRUCTURE AS APPROVED BY THE MIAMI DADE COUNTY OFFICE OF EMERGENCY MANAGEMENT AND THE STATE OF FLORIDA DIVISION OF EMERGENCY MANAGEMENT THROUGH AN APPLICATION PROCESS THROUGH FEDERAL EMERGENCY MANAGEMENT AGENCY PROGRAM (FEMA) , PROVIDING FOR EFFECTIVE DATE.

WHEREAS, The Mayor and City Commission of the City of West Miami submitted two projects for consideration and approval that have been approved by Miami Dade County under the LMS (Local Mitigation Strategy Plan) known as HMGP, and

WHEREAS, The City of West Miami has two applications before the LMS for approval (1) for the City of West Miami Police Department Expansion Project and (1) City of West Miami Recreation Center Expansion Project, and

WHEREAS, The City of West Miami's projects have been approved by Miami Dade County Office of Emergency Management along with other projects submitted by Miami Dade County and other cities located in Miami Dade County, and


