



RESOLUTION # 2020-54

A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF CITY OF WEST MIAMI AUTHORIZING THE CITY MANAGER TO ACCEPT A DONATION FOR THE SECOND MEAL PROGRAM FOR NEEDY ELDERLY ORIGINALLY APPLIED AND FUNDED BY THE OFFICE OF DISTRICT SIX COMMISSION, VICE CHAIR REBECA SOSA THROUGH A COMMITTEE BASED ORGANIZATION (CBD) DISCRETIONARY RESERVED AND OFFICE FUNDS LATER SUPPLEMENTED BY THE INTERLOCAL AGREEMENT FOR FEDERALLY FUNDED SUBAWARDS (EXHIBITS A, B, C AND D) IN THE AMOUNT OF \$239,990.00 FOR 190 ADDITIONAL SENIOR CENTER MEALS, FIVE DAYS PER WEEK FOR A PERIOD COMMENCING APRIL 6, 2020 THROUGH DECEMBER 31, 2020 FOR A PRICE OF \$5.50 PER MEAL; CONTRACTING THE SERVICE OF RENAISSANCE BALLROOM DURING THE COVID19 PANDEMIC; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, commencing in April 6, 2020 Commission Vice Chair, Rebeca Sosa procured on several occasions, funding to provide for a second meal for the elderly throughout District 6 and specifically the City of West Miami; and

WHEREAS, through the auspices of Commissioner Vice Chair Rebeca Sosa, additional federal funded subawards were provided; and

WHEREAS, further correspondence was received from the Department of Treasury on July 2 and July 31, 2020 setting forth Coronavirus Relief Fund reporting requirements (Exhibits A, B and C); and

WHEREAS, a Memorandum of Understanding between Miami-Dade County and the City of West Miami to the effect of Miami-Dade County reimbursing the City of West Miami the amount of \$239,990.00 for a second meal distribution for the elderly, executed by the County on September 11, 2020 (Exhibit D).

NOW, THEREFORE, BE IT RESOLVED by the City Commission of the City of West Miami as follows:

Section 1. The foregoing "whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption thereof.

Section 2. The City Manager is hereby authorized, to carry out the terms and conditions of the federally funded grant award and accepting the donation of the second meal program offered by the District Six Commissioner, Vice Chair, Rebeca Sosa in the amount of \$239,900.00 for the purpose of adding 190 meals, 5 days per week to be distributed to the elderly in District 6 area of the City of West Miami.

Section 3. If any section, subsection, clause or provision of this resolution is held invalid, the remainder shall not be affected by such invalidity.

Section 4. All resolutions or parts of resolutions in conflict herewith shall be and hereby are repealed.

Section 5. This resolution shall take effect immediately upon adoption.
