



**RESOLUTION # 2021-28**

**RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF WEST ACCEPTING/REJECTING THE RECOMMENDATION BY THE OFFICE OF THE CITY MANAGER TO REJECT ALL BIDS SUBMITTED FOR THE CURB AND PAVER REPLACEMENT PROJECT IN FRONT OF CITY HALL; PROVIDING FOR EFFECTIVE DATE.**

**WHEREAS**, an Invitation to Bid was issued for the replacement of worn out pavers and curb to be installed at the entrance of City Hall and the Community Center, and

**WHEREAS**, originally, only one bidder submitted a response and estimated cost, to wit: Southeastern Engineering Contractors, Inc., whose bid was rejected by the Administration, and

**WHEREAS**, on May 3<sup>rd</sup>, 4<sup>th</sup>, 5<sup>th</sup> and 6<sup>th</sup>, 2021 the bid for the Curb and Paver Replacement was re-advertised, and

**WHEREAS**, one bidder responded to the re-advertised Invitation to Bid, and

**WHEREAS**, on June 10, 2021, the bids were opened by Clerk of the City of West Miami, and

**WHEREAS**, the City received a bid proposal from John Bell Construction, Inc., in the amount of \$89,794.23, and

**WHEREAS**, the City Administration has determined that the bid proposal from John Bell Construction, Inc., in the amount of \$89,794.23 is above the projected budget available for said work, and

**WHEREAS**, the City Manager has recommended that the bid proposal by John Bell Construction, Inc., being above the budget available for such project, be rejected.

**NOW, THEREFORE, BE IT RESOLVED** by the City Commission of the City of West Miami as follows:

**Section 1.** The foregoing "whereas" clauses and heading are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption thereof.

**Section 2.** The and City Commission accepts/denies the recommendation from the Office of the City Manager rejecting the bid submitted by John Bell Construction, Inc., as it surpasses the estimated budget for the above-mentioned improvement.

**Section 3.** The City Manager is hereby authorized to reject the above-captioned bid.

**Section 4.** This Resolution shall take effect immediately upon passage by the City Commission and signature of the Mayor.
