

RESOLUTION # 2022-67

RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF WEST MIAMI AUTHORIZING THE CITY MANAGER TO EXECUTE THE INTERLOCAL AGREEMENT BETWEEN THE CITY OF WEST MIAMI AND MIAMI DADE COUNTY OFFICE OF MANAGEMENT AND BUDGET; ACCEPTING A DONATION BY DISTRICT SIX COMMISSIONER AND APPROVED BY THE BOARD OF COUNTY COMMISSION ON OCTOBER 6TH, 2022 IN THE AMOUNT OF SIXTY-SEVEN THOUSAND DOLLARS (\$67,000) FOR THE PURCHASE OF A 2023 FORD F-150 AWD PICK UP TRUCK TO BE EQUIPPED WITH PUBLIC SAFETY EQUIPMENT AND 22 BALLISTIC SHIELDS; PROVIDING FOR INCLUSION OF EXHIBITS TO INCLUDE THE SCOPE OF THE WORK, BUDGET FORMS AND THE INTERLOCAL AGREEMENT SIGNED BY THE PARTIES; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, through the auspices of our district Miami-Dade County Commissioner Rebeca Sosa on October 6th, 2022, the Board of County Commission of Miami-Dade County approved an allocation of Sixty-Seven Thousand Dollars (\$67,000.00) to the City of West Miami for the purchase of a 2023 Ford F-150 AWD Pick Up Truck to be equipped with public safety equipment and 22 ballistic shields; and

WHEREAS, the County and the City of West Miami must enter in an interlocal agreement in order to implement the aforementioned donation of funds; and

WHEREAS, the City Administration needs the approval of the City Commission to execute the aforementioned interlocal agreement; and

WHEREAS, the City Commission wishes to express the gratitude of the City of West Miami Commission, Administration and citizens in general to Commissioner Rebeca Sosa and instruct the City Manager to correspond to Commissioner Sosa to that effect.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COMMISSION OF THE CITY OF WEST MIAM! THAT:

SECTION 1. The aforementioned statements are true and correct and adopted as is fully stated herein.

SECTION 2. The City Commission accepts to enter into an Interlocal Agreement with Miami-Dade County to formalize the donation allocated for the purchase of the aforementioned equipment.

SECTION 3. The City Commission authorizes the City Manager to enter and execute any and all documents including the Interlocal Agreement marked as Exhibit "A" to implement and accept the donation from Commissioner Rebeca Sosa in the amount of Sixty-Seven Thousand Dollars (\$ 67,000.00).

SECTION 4. Instruct the City Manager to correspond with District Commissioner Rebeca Sosa expressing our gratitude for her everlasting efforts benefiting the City of West Miami.

SECTION 5. This Resolution shall take effect immediately upon passage by the City Commission and signature of the Mayor.
