



**RESOLUTION # 2023-22**

**RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF WEST MIAMI INSTRUCTING THE OFFICE OF THE CITY MANAGER TO NEGOTIATE A BETTER LOCATION FOR THE ROLLS OF CABLE INSTALLED BY AT&T OR COMCAST CABLE THAT HAS RESULTED AN UNSIGHTLY UPGRADE IN THE CITY OF WEST MIAMI WHERE QUALITY OF LIFE IS A PRIORITY TO THE MAYOR AND CITY COMMISSION AND THE RESIDENTS OF THE CITY OF WEST MIAMI; PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS**, the City of West Miami Mayor, City Commission and officials have strived to achieve, a beautiful community where citizens enjoy quality of life; and

**WHEREAS**, the citizens of the City of West Miami proudly collaborate to the maintenance of an enjoyable hometown atmosphere leading to peace, tranquility and enjoyment of life; and

**WHEREAS**, The aesthetics of the rolled black cables throughout the City of West Miami goes against the vision of the City of West Miami quality of life with respect to beautification efforts; and

**WHEREAS**, The Mayor and City Commissioners are requesting that the City Manager meet with AT&T and COMCAST CABLE in an effort to determine if anything can be done to mitigate the blight created by the Black Role of Cables citywide, and

**NOW, THEREFORE, BE IT RESOLVED** by the City Commission of the City of West Miami as follows:

**Section 1.** That the foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

**Section 2.** The City Commission would have preferred a more aesthetically pleasing solution for this project and would like to open negotiations to achieve our desired goal.

**Section 3.** The City Commission instructs the City Manager to, immediately,

meet with AT&T and COMCAST CABLE to request a reconsideration of this project and provide alternatives to the Mayor and City Commission for re-wiring.

**Section 4.** All Resolutions and parts of Resolutions in conflict herewith are repealed.

**Section 5.** This Resolution shall become effective immediately upon its passage.
