RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF WEST MIAMI APPROVING A VOLUNTARY COOPERATION AND OPERATIONAL ASSISTANCE MUTUAL AID AGREEMENT BETWEEN THE CITY OF WEST MIAMI AND THE SCHOOL BOARD OF MIAMI DADE COUNTY POLICE DEPARTMENT AS BETTER DESCRIBED IN EXHIBIT A; AUTHORIZING THE CITY MANAGER TO EXECUTE ANY AND ALL DOCUMENTS REQUIRED TO IMPLEMENT SUCH COOPERATION AND OPERATIONAL ASSISTANCE AGREEMENT BETWEEN CITY OF WEST MIAMI AND MIAMI DADE COUNTY SCHOOL BOARD POLICE DEPARTMENT; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the City of West Miami and the Miami Dade County School Board Police Department strive to ensure public safety in their respective jurisdictions; and

WHEREAS, the City Manager and Chief of Police of the City of West Miami strongly recommend the adoption and execution of the attached document.

NOW, THEREFORE, BE IT RESOLVED by the City Commission of the City of West Miami as follows:

Section 1. The foregoing "whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption thereof.

Section 2. The City Commission accepts the recommendation of the City of West Miami Manager and Chief of Police for the adoption and execution of the Cooperation and Operational Assistance Mutual Aid Agreement, attached hereto and made a part hereof as **Exhibit A**.

Section 3. The City Manager is authorized execute any and all documents necessary to effectuate the Cooperation and Operational Assistance Mutual Aid Agreement.

Section 5. All Resolutions and parts of Resolutions in conflict herewith are repealed.

Section 6. This Resolution shall become effective immediately upon its passage.
