



RESOLUTION # 2023-36

A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF WEST MIAMI, FLORIDA, AUTHORIZING THE CITY MANAGER TO COMPENSATE ADDITIONAL SERVICES IN THE CONTRACT BETWEEN THE CITY OF WEST MIAMI AND ECOSTRATA SERVICES FOR THE WORK IN CONNECTION WITH THE GRANT BETWEEN THE CITY OF WEST MIAMI AND EPA IN THE AMOUNT OF THREE MILLION DOLLARS FOR THE CONTINUATION OF THE "POTABLE WATER IMPROVEMENT PROJECT"; SAID FEES SHALL BE PAID FROM THE EPA GRANT; INSTRUCTING THE OFFICE OF THE CITY MANAGER TO FUND THE ADDITIONAL AMOUNT OF \$12,00.00 PER YEAR FOR A PERIOD OF ONE YEAR COMMENCING JUNE 1ST, 2023 THROUGH MAY 31ST, 2024; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the City of West Miami approved Resolution 2021-47 approving the recommendation of the City Manager to extend the contract as included in Exhibit A to Resolution 2021-47; and

WHEREAS, Ecostrata Services will provide additional services as stated in the heading of this resolution; and

WHEREAS, the City Commission desires to accept the recommendation of the City Manager to compensate Ecostrata Services for an additional \$1,000 per month commencing June 1, 2023 and ending May 31, 2024.

NOW, THEREFORE, BE IT RESOLVED by the City Commission of the City of West Miami as follows:

Section 1. The foregoing "whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption thereof.

Section 2. City Commission instructs the City Manager to compensate Ecostrata Services with an additional \$1,000 per month for a period of one (1) year for

additional services provided to City of West Miami with reference to the Potable Water Improvement Project.

Section 3. The City Clerk is instructed to fund the additional payment to Ecostrata Services in the full yearly amount of \$12,000.00 through the EPA Grant.

Section 4. This Resolution shall take effect immediately upon passage by the City Commission and signature by the Mayor.

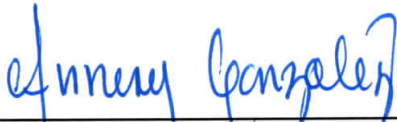
