

RESOLUTION # 2023-51

A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF WEST MIAMI, FLORIDA, INSTRUCTING THE CITY MANAGER TO ADVERTISE A REQUEST FOR PROPOSAL (RFP) FROM QUALIFIED VENDORS TO PROVIDE FOR THE INSTALLATION OF "PUSH BUTTON CONTROL" DEVICES AT THE INTERSECTION OF S.W. 62ND AVENUE AND S.W. [STREET]; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the City of West Miami recognizes the need to enhance pedestrian safety and improve traffic flow at the intersection of S.W. 62nd Avenue and S.W. [Street]; and

WHEREAS, the installation of "push button control" devices at this intersection has been identified as an effective measure to address these concerns; and

WHEREAS, the City Commission deems it necessary and appropriate to solicit proposals from qualified vendors for the installation of said devices.

NOW, THEREFORE, BE IT RESOLVED by the City Commission of the City of West Miami as follows:

Section 1. The foregoing "whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption thereof.

Section 2. The City Manager is hereby instructed to advertise a Request for Proposal (RFP) seeking proposals from qualified vendors for the installation of "push button control" devices at the intersection of S.W. 62nd Avenue and S.W. [Street].

Section 3. The RFP shall outline the necessary specifications, requirements, and timeline for the installation of the "push button control" devices. Vendors submitting proposals must meet the qualifications specified in the RFP.

Section 4. The City Manager, in consultation with relevant city departments, shall evaluate the received proposals based on criteria such as vendor experience, cost, implementation plan, and overall suitability for the project. Following the evaluation process, the City Manager shall present the recommended vendor to the City Commission for approval.

Section 5. The necessary funds for the installation of the "push button control" devices shall be allocated from the appropriate budgetary resources. The City Manager is authorized to take any necessary steps to secure the funding and ensure its availability for the project.

Section 6. This Resolution shall take effect immediately upon passage by the City Commission and signature by the Mayor.
