



**RESOLUTION # 2023-60**

**A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF WEST MIAMI, FLORIDA, AMENDING RESOLUTION 2021-40 BY EXECUTING AN INTERLOCAL AGREEMENT BY AND BETWEEN THE CITIZENS INDEPENDENT TRANSPORTATION TRUST (CITT) AND THE CITY OF WEST MIAMI OFFERING A NEW ON DEMAND TRANSIT SERVICE TO THE CITIZENS OF WEST MIAMI; TO BE FUNDED BY SURTAX PROCEEDS AND GRANT BY THE STATE OF FLORIDA DEPARTMENT OF TRANSPORTATION; PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS**, the City has, in the past, offered fixed rate transportation services to the citizens of the City of West Miami; and

**WHEREAS**, on demand transportation services offers to facilitate and improve the community's health and well-being; and

**WHEREAS**, on demand transportation services increases efficiency and decrease road congestion throughout the City; and

**WHEREAS**, on demand transportation services helps to reduce traffic and offers flexibility to citizens as well as improves user experience over fixed transit routes; and

**WHEREAS**, the City Commission desires to offer this on demand transportation service to the citizens of the City of West Miami.

**NOW, THEREFORE, BE IT RESOLVED** by the City Commission of the City of West Miami as follows:

**Section 1.** The foregoing "whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption thereof.

**Section 2.** The City Manager is hereby instructed and authorized to execute any and all documents of that certain interlocal agreement by the Citizens Independent Transportation Trust (CITT) and the City of West Miami as better described in the attached Exhibit "A," offering on demand transportation services to the City of West Miami.

**Section 3.** This Resolution shall take effect immediately upon passage by the City Commission and signature by the Mayor.



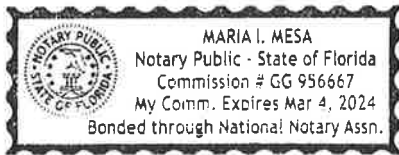
