**A RESOLUTION OF THE MAYOR AND THE CITY COMMISSION OF THE CITY OF WEST MIAMI RELATING TO MEDIUM EQUIPMENT PURCHASE OF A VERMEER SC-382 STUMP CUTTER FROM VERMEER SOUTHEAST SALE AND SERVICE, INC. UNDER THE COOPERATIVE PURCHASE PROGRAM FROM THE FLORIDA SHERIFFS' ASSOCIATION CONTRACT # FSA20-EQUIP18.0 IN THE AMOUNT OF THIRTY-EIGHT THOUSAND EIGHT HUNDRED AND FIFTY-FIVE DOLLARS AND ZERO CENTS (\$ 38,855.00) AND PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS**, in order for the City to provide great service to its residents this purchase is essential for the maintenance and beautification of City streets; and

**WHEREAS**, the City has an opportunity to purchase this equipment utilizing its reserves set aside for medium machinery costs; and

**NOW, THEREFORE BE IT RESOLVED** by the City Commission of the City of West Miami as follows:

Section 1: The City of West Miami hereby accepts the purchase of a Vermeer SC-382 Self Propelled Stump Cutter in the amount of Thirty-Eight Thousand Eight Hundred and Fifty-Five Dollars with Zero Cents (\$ 38,855.00) and directs the City Manager to create a Purchase Order in that amount to Vermeer Southeast Sales and Service, Inc.


Section 2: This Resolution shall take effect immediately upon approval.


