



RESOLUTION # 2023-85

A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF WEST MIAMI, FLORIDA, APPROVING *NUNC PRO TUNC* TO SEPTEMBER 21, 2023 THE EXECUTION OF THE 2024-2026 URBAN QUALIFICATION COOPERATION AGREEMENT BETWEEN MIAMI-DADE COUNTY AND THE CITY OF WEST MIAMI ALLOWING THE CITY TO SUBMIT FUNDING REQUESTS THROUGH MIAMI-DADE COUNTY FOR ASSISTANCE FROM THE COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG), THE HOME INVESTMENT PARTNERSHIPS (HOME) AND THE EMERGENCY SOLUTIONS GRANT (ESG), WHICH ARE FEDERAL ASSISTANCE PROGRAMS ADMINISTERED BY THE DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT (HUD), PROVIDED THAT THE CITY MEETS THE ELIGIBILITY CRITERIA DEFINED UNDER EACH PROGRAM; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, on August 1, 2023, the City of West Miami received correspondence from the Miami-Dade County Public Housing & Community Development Department informing the City of the county's upcoming re-qualification as an "Entitlement jurisdiction" for 2024 to 2026, attached hereto and made a part hereof as Exhibit "A"; and

WHEREAS, pursuant to the above-captioned correspondence, participation in the Urban Qualification Cooperation Agreement with Miami-Dade County would make the City eligible to apply for CDBG, HOME and ESG funding programs available through HUD; and

WHEREAS, the City has been the beneficiary of CDBG funded projects in the past to renovate the Senior Center and expand the Garden Club Park; and

WHEREAS, the City has expressed its desire to be included in the County's jurisdiction for Federal Funds for each three-year qualification period; and

WHEREAS, the City has received said agreement, attached hereto and made a part hereof as Exhibit "B," which is also listed as County's Resolution Number 1058-11; and

WHEREAS, the City is required to execute this agreement prior to September 26, 2023 in order that the County can execute and remit the agreement to The Department of Housing & Urban Development (HUD) by September 29, 2023; and

WHEREAS, the agreement will remain in effect from 2024 to 2026 and during that period, the City may receive an allocation under the CDBG and HOME Programs through the County's Request for Application Process.

NOW, THEREFORE BE IT RESOLVED by the City Commission of the City of West Miami as follows:

Section 1: The foregoing "whereas" clauses and heading are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption thereof.

Section 2: The City of West Miami hereby retroactively approves the execution of the Urban Qualification Cooperation Agreement with Miami-Dade County.

Section 3: The City Commission hereby agree to participate as a Miami-Dade County Entitlement jurisdiction for the CDBG three-year qualification period of 2024-2026.

Section 4: The resolution shall take effect *Nunc Pro Tunc* September 21, 2023 to as effective date.
