



RESOLUTION # 2023-89

A RESOLUTION OF THE MAYOR AND THE CITY COMMISSION OF THE CITY OF WEST MIAMI PERTAINING TO PROCUREMENT, SELECTING AND APPROVING THE EXPENSE TO MAGGOLC, INC. AS THE LOWEST MOST RESPONSIVE RESPONSIBLE BIDDER TO CONSTRUCT THE IMPROVEMENTS BASED ON THE CITY'S INVITATION TO BID (ITB) # 2023-20-001 TITLED "POTABLE WATER SYSTEM IMPROVEMENT – PHASE II" IN THE AMOUNT NOT TO EXCEED THREE MILLION DOLLARS (\$ 3,000,000) OFFERED TO THE CITY BY THE ENVIRONMENTAL PROTECTION AGENCY (EPA).

WHEREAS, the City advertised an Invitation to Bid (ITB) # 2023-20-001 "Potable Water System Improvement – Phase II on August 16th, 2023; and

WHEREAS, the City received a total of five (5) bids on September 13th, 2023, Maggolc, Inc, being the lowest most responsive responsible bidder; and

WHEREAS, the total amount of the bid although the lowest, exceeded the grant amount of 3 million dollars from the department of Environmental Protection Agency (EPA) ; and

WHEREAS, the City shall instruct the engineer to reduce the scope to accommodate the budget set for this project; and

WHEREAS, the excess scope shall be transferred to Phase III watermain improvements.

NOW, THEREFORE BE IT RESOLVED by the City Commission of the City of West Miami as follows:

Section 1: The foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made specific part of this Resolution upon adoption thereof.

Section 2: The City Commission hereby accepts the recommendation of Maggolc, Inc. to construct the watermain improvements specified on ITB# 2023-20-001 "Potable Water System Improvement-Phase II" in the amount not to exceed Three Million Dollars (\$ 3,000,000.00).

Section 3: The City Commission hereby authorizes the City Manager to sign a contract with Maggolc, Inc. to complete Phase II of the water main project for the City.

Section 4: This Resolution shall become effective upon its adoption.
