



RESOLUTION # 2024-53

A RESOLUTION OF THE CITY OF WEST MIAMI, FLORIDA, DETERMINING THE PROPOSED MILLAGE RATE FOR FISCAL YEAR 2024-2025; SETTING THE DATE, TIME, AND PLACE FOR THE PUBLIC HEARINGS REQUIRED BY STATE LAW; DIRECTING STAFF TO TRANSMIT NECESSARY DOCUMENTATION PURSUANT TO THE REQUIREMENTS OF FLORIDA STATUTES AND THE RULES AND REGULATIONS OF THE DEPARTMENT OF REVENUE OF THE STATE OF FLORIDA; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, on June 30, 2024, the Property Appraiser of Miami-Dade County, Florida, served upon the City of West Miami a "Certification of Taxable Value" certifying to the City of West Miami its taxable value; and

WHEREAS, Florida Statute 200.065 requires that within thirty-five (35) days of service of the Certification of Taxable Value upon a municipality, said municipality shall furnish to the Property Appraiser the proposed millage rate and the date, time, and place at which public hearings will be held to consider the millage rate and the proposed capital and operating budget for Fiscal Year 2024-2025.

NOW, THEREFORE, BE IT RESOLVED by the City Commission of the City of West Miami as follows:

Section 1. In order to provide funds to cover all appropriations set forth in the 2024-2025 Final budget of the City, there shall be and there is hereby proposed to be levied upon the assessed valuation of all taxable real and personal property in the City of West Miami, a tax of \$4.9500 per each \$1,000.00 of assessed valuation as shown on the real and personal property assessment rolls for 2024 for the calendar year beginning January 1st, 2024; and, as provided by Ordinance 133 as codified in sub-section 11-2 of the West Miami Code, and there is hereby proposed to levy thereupon a tax of \$1.00 per \$1,000.00 valuation for the playground and Recreation Fund established by said Ordinance. **For a total combined millage rate of \$5.9500.**

Section 2. That the City Commission hereby sets the date, time, and place of the budget hearings required by Florida Statutes as follows:

Section 3. That the City Manager or designee is hereby directed to transmit all necessary documentation in compliance with the rules and regulations of the Florida Department of Revenue on their Internet-based system for completing and submitting documents for Florida's Truth-In-Millage (TRIM) and maximum millage oversight process.

Section 4. This resolution shall be effective immediately upon its adoption.
