A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF WEST MIAMI, FLORIDA; RELATING TO GRANTS; APPROVING THE AGREEMENT BETWEEN THE CITY OF WEST MIAMI AND THE U.S. DEPARTMENT OF TRANSPORTATION THROUGH THE SAFE STREETS AND ROADS FOR ALL (SS4A) FEDERAL GRANT PROGRAM TO DEVELOP A WEST MIAMI TRANSPORTATION ACTION PLAN; ACCEPTING THE GRANT TOTAL AMOUNT OF ONE HUNDRED AND TWO THOUSAND, FOUR-HUNDRED (\$102,400) DOLLARS TO COMPLETE A WEST MIAMI TRANSPORTATION ACTION PLAN; AUTHORIZING THE CITY MANAGER TO EXECUTE SAID AGREEMENT AND OTHER RELATED DOCUMENTS TO COMPLETE THE PROJECT; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City of West Miami previously submitted a grant application to the Department of Transportation (DOT) requesting assistance from the Safe Streets and Roads for All Discretionary Grant program to fund the development of a City-wide Transportation Action Plan; and

WHEREAS, the City was successful in securing grant funding in the amount of one hundred and two thousand, four-hundred (\$102,400) dollars for the proposed project; and

WHEREAS, the City desires to move forward with the acceptance of the grant award and enter into the agreement with the Department of Transportation (DOT) and Federal Highway Administration (FHWA).

NOW, THEREFORE BE IT RESOLVED by the City Commission of the City of West Miami as follows:

THE ABOVE WHEREAS' ARE ADOPTED HEREIN AS PART OF THIS RESOLUTION.

Section 1: The foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made specific part of this Resolution upon adoption.

Section 2: The City Commission hereby accepts the Federal grant for \$102,400 from the U.S. Department of Transportation Federal Highway Administration Office of Safety.

Section 3: The Federal Award No. 693JJ32440272 between the United States Department of Transportation (DOT), Federal Highway Administration (FHWA) and the City of West Miami is hereby approved.

Section 4: The resolution shall take effect immediately upon adoption.
