



## RESOLUTION # 2024-63

**A RESOLUTION OF THE MAYOR AND THE CITY COMMISSION OF THE CITY OF WEST MIAMI AUTHORIZING THE CITY MANAGER TO EXECUTE A CHANGE ORDER WITH JOHN BELL CONSTRUCTION, INC. IN THE AMOUNT OF FIFTY-SEVEN THOUSAND TWO HUNDRED FORTY-SIX DOLLARS (\$57,246.00) FOR ADDITIONAL WORK ASSOCIATED WITH THE BASKETBALL COURT FOUNDATION PADS AT THE WEST MIAMI RECREATION CENTER; PROVIDING FOR FUNDING; PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS**, the City of West Miami is currently undertaking improvements at the West Miami Recreation Center, including the construction of basketball court foundation pads; and

**WHEREAS**, it has been determined that additional work is necessary for the proper completion of the project, including demolition and removal of existing asphalt and fence, excavation, surveying, layout, compaction testing, rebar installation including dowels, concrete pouring, concrete testing, and project management and supervision; and

**WHEREAS**, John Bell Construction, Inc. has submitted a Change Order proposal (PCO #001) for the additional work required, at a total cost of Fifty-Seven Thousand Two Hundred Forty-Six Dollars (\$57,246.00); and

**WHEREAS**, the City Commission finds that approving this Change Order is in the best interest of the City to ensure the successful and timely completion of the project.

**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COMMISSION OF THE CITY OF WEST MIAMI AS FOLLOWS:**

**Section 1.** The aforementioned "whereas" clauses are ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

**Section 2.** The City Manager is hereby authorized to execute the Change Order with John Bell Construction, Inc. in the amount of Fifty-Seven Thousand Two Hundred Forty-Six Dollars (\$57,246.00) for the additional work associated with the basketball court foundation pads at the West Miami Recreation Center.

**Section 3.** Funding for this Change Order shall be provided from the City's allocated project funds.

**Section 4.** This Resolution shall take effect immediately upon adoption.
