



RESOLUTION # 2024-64

A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF WEST MIAMI, FLORIDA; RELATING TO GRANTS; APPROVING THE PURCHASE OF EXERCISE EQUIPMENT TO BE INSTALLED AT COOPER PARK RELATED TO THE FRDAP GRANT AGREEMENT NO. A24068; ACCEPTING THE QUOTE RECEIVED FROM OUTDOOR WORKOUT SUPPLY IN THE AMOUNT OF TWENTY-SIX THOUSAND NINE HUNDRED AND FIFTY-FOUR DOLLARS (\$26,954); AUTHORIZING THE CITY MANAGER TO PURCHASE AND HAVE EQUIPMENT INSTALLED; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City of West Miami previously submitted a grant application to the Florida Department of Environmental Protection (FDEP) requesting assistance from the Florida Recreational Development Assistance Program (FRDAP) to help fund needed improvements to Cooper Parks outdoor exercise area; and

WHEREAS, the City Commission adopted Resolution No. 2022-53 authorizing the submission of said application; and

WHEREAS, the City was successful in securing grant funding in the amount of fifty-thousand (\$50,000) dollars with no match required and accepted the grant funds via Resolution No. 2024-07; and

WHEREAS, staff requested quotes from 5 outdoor equipment companies and received back 3 quotes and have selected the lowest price with all Parks Committee approved equipment from Outdoor Workout Supply; and

WHEREAS, the City desires to move forward with the received quote from Outdoor Workout Supply to begin coordinating delivery and installation.

NOW, THEREFORE BE IT RESOLVED by the City Commission of the City of West Miami as follows:

THE ABOVE WHEREAS' ARE ADOPTED HEREIN AS PART OF THIS RESOLUTION.

Section 1: The City Commission hereby approves the purchase of the exercise equipment to be installed at Cooper Park Related to FRDAP Grant #A24068.

Section 2: The City Commission hereby accepts the quote from Outdoor Workout Supply in the amount of twenty-six thousand, five hundred and fifty-four dollars (\$26,554).

Section 4: The City Manager is hereby authorized to purchase exercise equipment for installation from Outdoor Workout Supply.

Section 4: The resolution shall take effect immediately upon its adoption.


