



RESOLUTION # 2024-70

A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF WEST MIAMI APPROVING THE RECOMMENDATION FROM THE OFFICE OF THE CITY MANAGER TO ENGAGE BROWN AND BROWN INSURANCE AS THE PROVIDER FOR GENERAL LIABILITY, AND WORKER'S COMPENSATION COVERAGE FOR FISCAL YEAR COMMENCING 10/1/2024 THROUGH 9/30/2025; AUTHORIZING THE CITY MANAGER TO EXECUTE NECESSARY DOCUMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the City of West Miami seeks to ensure comprehensive insurance coverage for its employees, including general liability and worker's compensation; and

WHEREAS, the City Manager has recommended Brown and Brown Insurance Services, Inc, as the most suitable provider for the City's insurance needs for the fiscal year commencing 10/1/2024 through 9/30/2025; and

WHEREAS, the Town of Jupiter, Florida, has conducted a competitive bidding process on which the City of West Miami may rely in compliance with applicable competitive bidding requirements of law (commonly referred to as "piggybacking"); and

WHEREAS, the City of West Miami has determined that engaging Brown and Brown Insurance will provide continuity of care and services to the City's insured personnel.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF WEST MIAMI, FLORIDA:

Section 1. The above-stated "whereas" clauses are ratified and confirmed as being true and correct and are incorporated into this Resolution.

Section 2. The City Commission of the City of West Miami hereby approves the engagement of Brown and Brown Insurance Services, Inc ("Brown and Brown"), to provide general liability and worker's compensation insurance coverage for the City's eligible personnel for the fiscal year commencing 10/1/2024 through 9/30/2025.

Section 3. The City Manager is hereby authorized to execute any and all documentation necessary to engage Brown and Brown Insurance as the City's insurance provider, including but not limited to applications, contracts, and any related documents.

Section 4. This Resolution shall take effect immediately upon its passage and adoption by the City Commission and signature by the Mayor.
