



**RESOLUTION # 2024-74**

**RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF WEST MIAMI AUTHORIZING THE CITY MANAGER TO ACCEPT A MITIGATION OFFER IN THE AMOUNT OF SIX THOUSAND DOLLARS (\$6,000.00) FROM WASTE SERVICES OF FLORIDA, INC. NOW KNOWN AS WASTE CONNECTIONS OF FLORIDA, INC. ON CODE ENFORCEMENT LIEN FOR CODE VIOLATION; PROVIDING THAT IF PAYMENT IN FULL IS NOT PAID IN THIRTY (30) DAYS, THEN THE AMOUNT OWED SHALL REVERT TO THE ORIGINAL LIEN AMOUNT; PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS**, A Code Enforcement lien for code violation has been levied against Waste Services of Florida, Inc. Now Known As Waste Connections of Florida, Inc. under **Citation # 1605007 in the amount of \$108,944.25 Occupational License**; and

**WHEREAS**, the Mayor and City Commission have received a negotiated settlement offer in the amount of Six Thousand Dollars (\$6,000.00).

**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COMMISSION OF THE CITY OF WEST MIAMI AS FOLLOWS:**

**SECTION 1.** The aforementioned statements are true and correct and adopted as is fully stated herein.

**SECTION 2.** The City Manager is hereby authorized to accept the mitigation offer in the amount of Six Thousand Dollars (\$6,000.00) to settle Code Enforcement liens for code violation levied against Waste Services of Florida, Inc. Now Known As Waste Connections of Florida, Inc. under **Citation # 1605007 in the amount of \$108,944.25 Occupational License** and subsequently release said lien.

**SECTION 3.** This Resolution shall take effect immediately upon passage by the City Commission and signature of the Mayor.


