RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF WEST MIAMI AUTHORIZING THE CITY MANAGER TO ACCEPT A MITIGATION OFFER IN THE AMOUNT OF FIVE THOUSAND DOLLARS (\$5,000.00) FROM CRISTIAN DOMINGUEZ AND CRISTINA GONZALEZ ON CODE ENFORCEMENT LIENS FOR CODE VIOLATIONS AT THE PROPERTY LOCATED AT 6417 SW 10 TERR, WEST MIAMI, FL; PROVIDING THAT IF PAYMENT IN FULL IS NOT PAID IN THIRTY (30) DAYS THEN THE AMOUNT OWED SHALL REVERT TO THE ORIGINAL LIEN AMOUNT; PROVIDING FOR A N EFFECTIVE DATE.

WHEREAS, Code Enforcement liens for code violation has been levied against the property located at 6457-6459 SW 9 ST, West Miami, Florida under **Case # 1911010** in the amount of \$119,373.00, **Case # 1911009** in the amount of \$118,761.00, **Case # 2009023** in the amount of \$13,497.00, **Case # 2101005** in the amount of \$22,813.00, **Case # 2101006** in the amount of \$31,925.00, **Case # 2101007** in the amount of \$4,589.00, **Case # 2101008** in the amount of \$ 2,311.00 and **Case # 2105018** in the amount of \$31,653.00, totaling \$ 344,922.00; and

WHEREAS, the Mayor and City Commission have received a negotiated settlement offer in the amount of Five Thousand Dollars (\$5,000.00).

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COMMISSION OF THE CITY OF WEST MIAMI AS FOLLOWS:

SECTION 1. The aforementioned statements are true and correct and adopted as is fully stated herein.

SECTION 2. The City Manager is hereby authorized to accept the mitigation offer in the amount of Five Thousand Dollars (\$5,000.00) to settle Code Enforcement liens for code violations at 6417 SW 10 TERR, West Miami, Florida under **Case # 1911010** in the amount of \$119,373.00, **Case # 1911009** in the amount of \$118,761.00, **Case # 2009023** in the amount of \$13,497.00, **Case # 2101005** in the amount of \$22,813.00, **Case # 2101006** in the amount of \$31,925.00, **Case # 2101007** in the amount of \$4,589.00, **Case # 2101008** in the amount of \$ 2,311.00 and **Case # 2105018** in the amount of \$31,653.00, totaling \$ 344,922.00 and subsequently release said liens.

SECTION 3. This Resolution shall take effect immediately upon passage by the City Commission and signature of the Mayor.
