



## RESOLUTION # 2024-87

**A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF WEST MIAMI, FLORIDA; RELATING TO GRANTS; APPROVING THE INTERLOCAL AGREEMENT BETWEEN THE CITY OF WEST MIAMI AND MIAMI-DADE COUNTY TRANSPORTATION PLANNING ORGANIZATION (TPO) FY 2025 MUNICIPAL GRANT PROGRAM TO IMPLEMENT A FEASIBILITY STUDY TO IMPROVE MOBILITY, SAFETY, CONNECTIVITY, AND ACCESSIBILITY FOR PEDESTRIANS AND BICYCLISTS; ACCEPTING THE GRANT TOTAL AMOUNT OF EIGHTY THOUSAND (\$80,000) DOLLARS TO COMPLETE A WEST MIAMI STREETS BICYCLE & PEDESTRIAN SAFETY PLAN; AUTHORIZING THE CITY MANAGER TO EXECUTE SAID AGREEMENT AND OTHER GRANT RELATED DOCUMENTS AS REQUIRED; AND PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, the City of West Miami previously submitted a grant application to the Miami-Dade Transportation Planning Organization (TPO) requesting assistance from the Municipal Grant program to fund the development of a Complete Streets Bicycle & Pedestrian Safety Plan; and

**WHEREAS**, the City was successful in securing grant funding in the amount of eighty thousand (\$80,000) dollars for the proposed project; and

**WHEREAS**, the City desires to move forward with the acceptance of the grant award and enter into the Interlocal Agreement with the Miami-Dade Transportation Planning Organization (TPO).

**NOW, THEREFORE BE IT RESOLVED** by the City Commission of the City of West Miami as follows:

**THE ABOVE WHEREAS' ARE ADOPTED HEREIN AS PART OF THIS RESOLUTION.**

**Section 1:** The foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption.

**Section 2:** The City Commission hereby accepts the Federal grant for \$80,000 from the Miami-Dade Transportation Planning Organization.

**Section 3:** The Award of Streets Bicycle & Pedestrian Safety Plan between the Miami-Dade Transportation Planning Organization (TPO) and the City of West Miami is hereby approved.

**Section 4:** The resolution shall take effect immediately upon adoption.
