A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF WEST MIAMI, FLORIDA; RELATING TO GRANTS; ACCEPTING THE FUNDING AWARD FROM THE CHILDREN’S TRUST COMMUNITY ENGAGEMENT AND OUTREACH GRANT PROGRAM IN THE AMOUNT OF FIFTEEN THOUSAND (\$15,000) DOLLARS TO HELP FINANCE THE IMPLEMENTATION OF A SIX (6) WEEK STEM PROGRAM DURING THE 2025 MULTI-GENERATIONAL RECREATION CENTER SUMMER CAMP SESSION; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City of West Miami is dedicated to improving services to the community from school-aged to senior citizen status; we seek ways to implement programs, events, and services to make their experiences more educational, interesting, engaging and rewarding; and

WHEREAS, the City of West Miami previously submitted a grant application to The Children’s Trust requesting assistance from their Community Engagement & Community Outreach Grants Program for Direct Services to enhance Summer Programming with a 6-week STEM Program for students entering 6th to 8th grade; and

WHEREAS, the City was successful in securing grant funding in the amount of fifteen thousand (\$15,000) dollars with match of twenty-five thousand (\$25,000) dollars to fulfill programming costs; and

WHEREAS, the City desires to move forward with accepting the grant award and enter into an agreement with The Children’s Trust upon receipt before programming begins.

NOW, THEREFORE BE IT RESOLVED by the City Commission of the City of West Miami as follows:

THE ABOVE WHEREAS’ ARE ADOPTED HEREIN AS PART OF THIS RESOLUTION.

Section 1: The foregoing “Whereas” clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption.

Section 2: The City Commission hereby accepts the Locally Funded grant amount of \$15,000 from The Children’s Trust.

Section 3: The resolution shall take effect immediately upon approval.
