



## RESOLUTION # 2025-40

**A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF WEST MIAMI, FLORIDA; RELATING TO PROCUREMENT; APPROVING THE PURCHASE OF A SELECTION OF TRAINING EQUIPMENT PIECES FOR THE FIRST FLOOR EXERCISE AREA OF THE MULTI-GENERATIONAL RECREATION CENTER (MGRC); ACCEPTING LIFE FITNESS AS THE MOST RESPONSIVE VENDOR OF THE THREE (3) RECEIVED QUOTES; AUTHORIZING THE CITY MANAGER TO ENTER INTO CONTRACT WITH LIFE FITNESS, NOT TO EXCEED ONE HUNDRED AND FIFTY THOUSAND DOLLARS (\$150,000) TO BE FUNDED BY THE PARKS FEE SCHEDULE; AND PROVIDING AN EFFECTIVE DATE. (*Sponsored by Administration*)**

**WHEREAS**, the City Commission recognized the importance of expanding services and creating a community hub for wellness and fun; and

**WHEREAS**, the City Commission adopted Resolution No. 2024-29 authorizing the construction of a re-envisioned Multi-Generational Recreation Center (MGRC) as the new home to the Senior Activity Center; and

**WHEREAS**, the City reallocated ARPA funds to the new construction project; and

**WHEREAS**, the City Manager and staff requested quotes from 3 exercise equipment companies and after reviewing the equipment, costs and seeking guidance from the Parks & Recreation Advisory Board made the decision; and

**WHEREAS**, the City desires to move forward with the received quote from Life Fitness to begin coordinating delivery, layout and installation.

**NOW, THEREFORE BE IT RESOLVED** by the City Commission of the City of West Miami as follows:

**THE ABOVE WHEREAS' ARE ADOPTED HEREIN AS PART OF THIS RESOLUTION.**

Section 1: The City Commission hereby approves the purchase of the exercise equipment to be installed at the Multi-Generational Recreation Center (MGRC).

Section 2: The City Commission hereby accepts the selection of Life Fitness and approves that the cost cannot exceed one hundred and fifty thousand dollars (\$150,000).

Section 4: The City Manager is hereby authorized to purchase exercise equipment for installation from Life Fitness for the first floor of the MGRC.

Section 4: The resolution shall take effect immediately upon its adoption.
