A RESOLUTION OF THE MAYOR AND THE CITY COMMISSION OF THE CITY OF WEST MIAMI, ACCEPTING THE PROPOSAL FROM WATERWORKS METROLOGY, LLC. FOR THE PURCHASE OF 100 WATER METERS IN THE AMOUNT OF THIRTY-NINE THOUSAND ONE HUNDRED AND SEVENTY-FIVE DOLLARS AND ZERO CENTS (\$ 39,175.00); PROVIDING FOR AN EFFECTIVE DATE. (Sponsored by Administration)

WHEREAS, due to the growing number of residents and the need to replace old meters, it is imperative that the City takes the opportunity to purchase these meters for the continual accuracy in the readings; and

WHEREAS, the City already has in place meters and a billing system offered by Water Works Metrology; and

WHEREAS, the procurement department conducted a cost analysis on the meters and recommended Water Works Metrology to keep servicing the City; and

NOW, THEREFORE BE IT RESOLVED by the City Commission of the City of West Miami as follows:

SECTION 1. The City of West Miami hereby approves the purchase in the amount of Thirty-Nine Thousand One Hundred and Seventy-Five Dollars and Zero Cents (\$ 39,175.00) to Water Works Metrology, LLC.


SECTION 2. This Resolution shall take effect immediately upon approval.
