



**RESOLUTION # 2025-51**

**A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF WEST MIAMI, FLORIDA; RELATING TO PARKS AND RECREATION, ACCEPTING THE IMPLEMENTATION OF A GYM MEMBERSHIP FEE AT THE MULTI-GENERATIONAL RECREATION CENTER (MGRC); APPROVING THE ATTACHED FEE STRUCTURE FOR THE MGRC GYM; AUTHORIZING THE CITY MANAGER AND FINANCE DIRECTOR TO ESTABLISH, COLLECT AND MANAGE THIS REVENUE SOURCE; AND PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, the City of West Miami will operate and maintain a municipal gym as an amenity of its recreational facility, providing valuable health and wellness opportunities for residents and non-residents; and

**WHEREAS**, the Parks & Recreation Advisory Board (Parks Board) has been developing a Parks Fee Schedule to be adopted at a future date; and

**WHEREAS**, the Parks Board thoroughly and thoughtfully selected the gym equipment and compared membership fees of other similarly sized municipalities to assist with the fee schedule; and

**WHEREAS**, the operation and maintenance of the municipal gym will incur additional costs that will need to be offset; enacting user fees will assist in ensuring a quality gym facility; and

**WHEREAS**, it is the desire of the City Commission in support of the Parks Board to establish a clear, competitive and reasonable fee to ensure the long-term viability and accessibility of the municipal gym; and

**WHEREAS**, this gym membership fee will begin October 1, 2025 to coincide with the new Fiscal Year; and

**WHEREAS**, the gym membership will be advertised to residents for early VIP registration promotion; and

**WHEREAS**, the Commission accepts the gym membership fee structure.

**NOW, THEREFORE BE IT RESOLVED** by the City Commission of the City of West Miami as follows:

**THE ABOVE WHEREAS' ARE ADOPTED HEREIN AS PART OF THIS RESOLUTION.**

Section 1: The City Commission approves the attached Exhibit 'A' "Gym Membership Fees," to be charged for various gym membership types (e.g., monthly, annual, daily, guest).

Section 2: The Manager's Office, Finance Department and Parks Department are hereby authorized to collect the established fees for gym memberships in accordance with the adopted Fee Schedule beginning October 1, 2025.

Section 3: The resolution shall take effect immediately upon approval.
