



RESOLUTION # 2025-59

A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF WEST MIAMI APPROVING THE RECOMMENDATION OF THE ART ADVISORY BOARD FOR THE ACQUISITION AND INSTALLATION OF THE ART PIECE ENTITLED “ESCULTURAS DE FLORES” BY ARTIST HAROLD MARIN, TO BE PLACED AT EL PASEO, AT A PURCHASE PRICE OF TEN THOUSAND DOLLARS (\$10,000); PROVIDING FOR AUTHORIZATION; PROVIDING FOR AN EFFECTIVE DATE.
(Sponsored by Administration)

WHEREAS, the City of West Miami values the inclusion of public art installations that enhance the cultural, educational, and visual landscape of the community; and

WHEREAS, the Art Advisory Board has reviewed and recommended the placement of an art piece entitled “Esculturas De Flores” by artist Harold Marin; and

WHEREAS, the proposed art piece is approximately eight (8) to nine (9) feet in height (excluding the base), consisting of three (3) sculpted flowers with a predominant color of blue accented in gold; and

WHEREAS, the purchase price of the art piece is Ten Thousand Dollars (\$10,000); and

WHEREAS, the Mayor and City Commission desire to approve the acquisition and installation of “Esculturas De Flores” at El Paseo.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and City Commission of the City of West Miami as follows:

Section 1. The foregoing "whereas" clauses and heading are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption thereof.

Section 2. The Mayor and City Commission hereby approves the recommendation of the Art Advisory Board for the acquisition and installation of the art piece “Escultura De Flores” by artist Harold Marin, to be placed at El Paseo, at a purchase price of Ten Thousand Dollars (\$10,000.00).

Section 3. The City Manager is authorized to take all the necessary actions to carry out the acquisition and installation of said art piece.

Section 4. That this Resolution shall become effective upon its adoption.


