



RESOLUTION # 2025-60

A RESOLUTION OF THE MAYOR AND THE CITY COMMISSION OF THE CITY OF WEST MIAMI, ACCEPTING THE PROPOSAL FROM PEDRO JIMENEZ, INC. TO INSTALL FENCING FOR LORRAINE PARK IN THE AMOUNT OF EIGHT THOUSAND SEVEN HUNDRED AND ZERO CENTS (\$ 8,700.00); PROVIDING FOR AN EFFECTIVE DATE (Sponsored by Administration).

WHEREAS, the City Commission of the City of West Miami recognizes the need to enhance the safety, security, and maintenance of Loraine Park by installing a perimeter fence; and

WHEREAS in recent months, concerns have been raised by residents and staff regarding unauthorized entry, vandalism, and safety hazards within the park, making it necessary to explore fencing solutions that will enhance security and protect public property; and

WHEREAS, the City received two (2) proposals for this project and concluded that the aforementioned vendor was the lowest, most responsive responsible; and

WHEREAS, Chapter 2, Article IV, Section 2-74(b) provides that the Commission, by 4/5 vote, may authorize waving the requirement and procedure for waiver of purchasing; and

WHEREAS, the Administration finds that the procurement requirements should be waived due to this scope does not exceed the threshold for a full procurement process; and

NOW, THEREFORE, BE IT RESOLVED by the City Commission of the City of West Miami as follows:

Section 1: The foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption thereof.

Section 2: The City Commission hereby accepts the recommendation of Administration to waive procurement requirements of the City of West Miami Code of Ordinances.

Section 3: The City Commission hereby authorizes the City Manager to accept the proposal of Pedro Jimenez, Inc. for the installation of a fence at Loraine Park in the amount of Eight Thousand Seven Hundred Dollars and Zero Cents (\$ 8,700.00).

Section 4: This Resolution shall become effective upon its adoption.


