



RESOLUTION # 2025-63

A RESOLUTION OF THE MAYOR AND THE CITY COMMISSION OF THE CITY OF WEST MIAMI, ACCEPTING THE PROPOSALS FROM V & G CONSTRUCTION SOLUTIONS, CORP FOR CITY-WIDE STREET STRIPING FOR A TOTAL AMOUNT OF NINE THOUSAND NINE HUNDRED AND FIFTY DOLLARS AND ZERO CENTS (\$ 9,950.00); PROVIDING FOR AN EFFECTIVE DATE. (Sponsored by Administration)

WHEREAS, Throughout time the striping on the streets have faded or otherwise peeled off completely by weather and/or traffic; and

WHEREAS, the City would like to keep its aesthetic appearance by revitalizing the streets signage; and

WHEREAS, V & G Construction Solutions Corp has been a reputable and professional vendor for many years completing timed projects throughout the City and,

WHEREAS, Chapter 2, Article IV, Section 2-74(b) provides that the Commission, by 4/5 vote, may authorize waving the requirement and procedure for waiver of purchasing; and

WHEREAS, the Administration finds the procurement requirements should be waived due to the fact that the amount of the project is less than the \$ 25,000.00 threshold which does not require a full procurement process; and

NOW, THEREFORE BE IT RESOLVED by the City Commission of the City of West Miami as follows:

Section 1: The foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made specific part of this Resolution upon adoption thereof.

Section 2: The City Commission hereby accepts the recommendation of Administration to waive procurement requirements of the City of West Miami Code of Ordinances.

Section 3: The City Commission hereby authorizes the City Manager to accept the proposals of V & G Construction Solutions Corp. for the total amount of Nine Thousand Nine Hundred and Fifty Dollars and Zero Cents (\$ 9,950.00).

Section 5: This Resolution shall become effective upon its adoption.
