A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF WEST MIAMI, FLORIDA; RELATING TO PROCUREMENT, APPROVING SELECTION OF EXP US SERVICES, INC.; TO DEVELOP AN ACTION PLAN CONSISTING OF A SAFETY ANALYSIS OF ROADWAYS WITHIN THE CITY FUNDED BY THE U.S. DEPARTMENT OF TRANSPORTATION'S (USDOT) FEDERAL HIGHWAY ADMINISTRATION (FHWA); FOR RFP# 2025-20-008 "WEST MIAMI TRANSPORTATION ACTION PLAY"; AUTHORIZING THE CITY MANAGER TO EXECUTE A CONTRACT WITH EXP US SERVICES, INC., IN AN AMOUNT, NOT TO EXCEED, ONE HUNDRED TWENTY-EIGHT THOUSAND, DOLLARS AND ZERO CENTS (\$128,000.00) INCLUDING TEN THOUSAND DOLLARS AND ZERO CENTS (\$10,000.00) ALLOCATED FOR A DEMONSTRATION COMPONENT IN FULFILLMENT OF THE GRANT REQUIREMENTS; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City of West Miami is dedicated to providing a safe living, working and playing environment for its residents, local businesses, schools and guests; and

WHEREAS, the City secured funding from the USDOT's, FHWA's to develop a Comprehensive Transportation Action Plan; and

WHEREAS, the Commission approved and accepted the original grant agreement via Resolution No. 2024-58; and

WHEREAS, Procurement advertised a Request for Proposals on April 7, 2025 and closed the procurement process on May 6, 2025; and

WHEREAS, four proposers who attended the mandatory Pre-Bid Meeting on April 15, 2025 were the vendors able to apply; and

WHEREAS, due to the period of the project and the closeout of the grant, the city does not have the additional time to resolicit for these services; and

WHEREAS, the City desires to move forward with EXP US Services, Inc. as the sole proposer and enter into a contract to begin discussions on project execution.

NOW, THEREFORE BE IT RESOLVED by the City Commission of the City of West Miami as follows:

THE ABOVE WHEREAS' ARE ADOPTED HEREIN AS PART OF THIS RESOLUTION.

Section 1: The City Commission approves the selection of EXP US Services, Inc. as the selected Bidder to develop the West Miami Transportation Action Plan.

Section 2: The City Manager is hereby authorized to execute a contract with EXP US, Inc. for the development of said Action Plan.

Section 3: The resolution shall take effect immediately upon approval.
